A newborn baby boy came into a car seat checkup event restrained only by a seat belt. She made sure he left in a convertible car seat – and that his safety was made a priority. Since then, she has taught certification classes in Germany and other places around the world.

At this moment in time, when reaching and educating families has become more challenging, she is inspired by opportunities for forward-thinking solutions. Under the circumstances, she is excited to help shape the future of child passenger safety and considers it an honor to join the Board in this effort.

Phillips grew up in Southfield, MI. She earned a degree in interdisciplinary studies in social sciences from Michigan State University. She moved to Gainesville, VA, in 2012 and since has relocated to Arlington. In her free time, she loves to read and learn new skills. In fact, she is teaching herself how to sew right now.
