Welcome – Jennifer Pelky

- The Board was welcomed to the May 2023 full Board meeting.
- The Board was reminded that meetings are held in executive session.
- The public meeting minutes for the March 2023 full NCPSB meeting were reviewed.
 - Jessica thanked those who submitted comments via email for revisions to the minutes.
 Minor changes were made prior to the meeting (non-content related).
 - A motion was made and seconded to approve the March 2023 meeting minutes with the suggested edits.
 - The motion was approved.

Board Introductions/Activity – Jennifer Pelky

- All Members introduced themselves with a special welcome extended to incoming Members.
- Members participated in an icebreaker.

Partner Update: NHTSA Headquarters - Laura Dunn

- The following data sets are now available:
 - 2021 FARS

- 2021 Crash Report Sampling System (CRSS)
- 2021 Crash Investigation Sampling System (CISS)
- Estimates for the projected traffic fatalities for the first 9 months of 2022 have been released.
 - A .2% decrease was observed for the first 9 months.
- The Cost of Traffic Crashes in America has been released.
 - It was authored by Larry Blinko.
 - In 2019, traffic crashes cost America 340 billion dollars.
- National Heatstroke Prevention Day was May 1, 2023.
 - The campaign will continue for the season.
 - Assets from the Ad Council are available at www.trafficsafetymarketing.gov.
 - o Laura participated in an American Academy of Pediatrics podcast.
- Click-it or Ticket Campaign begins in May.
 - Earned media is running from May 8 June 15, 2023.
 - Paid media is running from May 15 June 4, 2023.
- NOPUS data collection will start two weeks after the Click-it or Ticket campaign ends.
- Laura mentioned that recent publications that have been released by the National Center for Statistics and Analysis. She highlighted the 2021 National Survey of the Use of Booster Seats (NSUBS) data.
 - Findings include:
 - More children are in harnessed car seats.
 - Less children are in booster seats.
 - More children are staying in harnessed car seats rather than early transition to seat belt.
- The National Association of State Emergency Medical Services Officials (NASEMSO) and NHTSA would like to announce a cooperative agreement to develop a crash test methodology for child transport and ambulances.

Amanda Jackson - NHTSA Regional Report

- Amanda reported that for technical assistance the Regional Operations Program is doing a deep dive using non-traditional data sources.
 - NHTSA is actively providing technical assistance to states that are interested. This
 includes a deep data dive, SWOT analysis and Roundtable discussion.
- · Regions Updates
 - Region 1
 - Maine recently held a child passenger safety training that allowed child passenger safety technicians to get their required seat sign-offs.
 - Region 4
 - Region 4 hosted an OP Virtual Bootcamp for Regions 4 and 5.
 - Car seat checks have been held at military bases in AL (Maxwell Air Force Base),
 GA (Fort Benning) and SC (Shaw Air Force Base).
 - Region representatives met with Jennifer Booge on May 30 to discuss the National Digital Car Seat Check Form.
 - o GA CPS Board met on April 25.
 - Region 5
 - The Illinois CPS Conference will be held June 27-28, 2023.
 - o In FY24, all grantees in IL funded by IDOT must use the NDCF.

- IL has 11 Technician skill updates, 7 CPST classes, and 3 renewal classes scheduled from now until the end of the grant year
- Region 7
 - o A car seat check event is scheduled at Fort Leavenworth in Kansas.
- Region Ten:
 - The NDCF Team (Jennifer Booge, Joe Powell, Amy Artuso) presented to Region 10 (Alaska, Montana, Idaho, Washington, Oregon) OP/CPS program managers in April.
 - They discussed how other states are using the NDCF data and lessons learned.
 - The NDCF Team also answered questions such as:
 - o How the data can be used for reporting and program purposes,
 - Accessing and understanding how to navigate the clean data dashboards and table tools available to each state program manager, etc.
 - Technician Courses have been held or are scheduled in all Region 10 states.
 - o A virtual OP/CPS Assessment was conducted in Idaho March 13-17, 2023.

Program Update: Safe Kids Worldwide – Krystal Phillips and Cass Herring

- Prevcon is coming up.
 - Safe Kids Worldwide will be celebrating its 35th anniversary.
- Safe Kids Worldwide is rolling out new strategic plan with a focus on equity in child safety specifically historically marginalized and underserved populations.
- May has several observances and activities for Safe Kids:
 - Back to School Day
 - National Heatstroke Awareness
 - Global Safety Week
 - CPST Month
- Please encourage National CPST Certification Training courses to be held during the summer months.
 - Course numbers decreased during the pandemic but are slowly increasing.
- Currently, there are almost 38,000 Technicians and Instructors.
- Safe Kids Worldwide is working on activities to improve the certification process including:
 - Website updates
 - Recertification processes
 - Equity and equality of all certification services

- Pediatric Vehicular Heatstroke Updates

 - Group delivery is available.



Curriculum Committee - Tammy Franks

- Car Seat Basics
 - There were 4,638 completions as of 4/30/23 with an average of 449 completions per month for January – March 2023.
 - The National Safety Council has been promoting the national training in magazines and newsletters and on social media.
 - The course has been used by car seat distribution programs, as a certification prerequisite and by car seat manufacturers.
- Child Passenger Learning Portal
 - We are now able to capture the reach of all webinars in the new learning management system. This will help us to determine interest for future webinars.



The green line is the initial webinar attendance.

- The blue line is the viewing of the webinar in the old learning management system based on guiz completions only.
- The orange line is course completions including the video and quiz in the new learning management system.
- Community education courses were not captured under the old system since we could not capture any data in that system.
- Hybrid National CPST Certification Training Courses
 - To date, there have been 51 completed Hybrid courses including pilot courses.
 - There are 8 active courses.
 - 10%+ of Instructors are Hybrid endorsed.
 - o 208 Hybrid-endorsed Instructors
 - 119 Active hybrid endorsement trainings
 - Cass and Tammy shared that successfully completion rates are comprable between the in-person and hybrid offering.
 - The Board discussed how to promote the Hybrid version and how to get past the negative "chatter". Recommendations include encouraging the completion of modules prior to the VILT Checkpoints and Instructors taking a more active role in mentoring students.
 - The Board discussed completing a one-year Hybrid report for dissemination.
 - The Board also identified the importance of tracking recertification rate for students who became certified in a hybrid course.
 - Tammy summed up the conversation stating that we will begin to pull data to promote the Hybrid, possibly create a dashboard as well. At the end of the one year mark, we will pull together a report to look at and work on social media and revisit the Hybrid model in October based on the data pull.
- Child Passenger Safety on School Buses National Training
 - The CPST Version in-person and hybrid offerings launched as of March 2023.
 - o The first course was held in Indiana with 15 CPSTs completing the course.
 - The Pupil Transportation Version (non-CPST) will launch late May.
 - Final field review will end next week.
 - The training calendar is at cpsboard.org/training-calendar.
 - It is routinely updated with new course listings
 - The videos from the curriculum are all posted on YouTube. One particular video: Safety Vests and Seat Mounts has had over 7,000 views. This is just after the launch of the curriculum!
 - Thank you to all who served as reviewers and/or shared your talent to the project!
- Car Seat Basics for Law Enforcement
 - This one-hour course is in development and will be ready by late summer.
 - There are two version: in-person and online.
- Wheelchair Transportation National Training
 - A workgroup started in April.
- 2024 National Child Passenger Safety Technician Certification Curriculum
 - The Board discussed the 2024 curriculum and suggested revisions to the curriculum.

Community Engagement Committee - Mandi Seethaler and Daniella Brown

- Ron Kremer provided a social media and website traffic report.
 - Mandi reminded Board members of the social media post schedule.
 - New members were provided ideas on how to create posts.
- Always a Board Member Initiative
 - Daniella and Mandi discussed quarterly meetings:
 - o June 2
 - September 8
 - December 11
 - Daniella explained the next steps for the meetings and stressed that engagement is key.
- CPS Coordinators Forums
 - Topics for upcoming forums were discussed.
 - o Content is needed for December. Please contact Mandi with any ideas.
- 2024 National CPS Awards
 - Nominations are now open through August 31, 2023.
 - Refer to the *Member Handbook* for the process overview.
 - The Board discussed the award nomination format.
 - Please help to promote the award nomination period.

Certification/Recertification Committee - Cass Herring and Justin Young

- Cass distributed recertification rates for January April 2023.
 - 4,975 CPSTs were eligible for recertification of which 2,690 recertified.
 - January 52%
 - o Feb 55%
 - March 54.9%
 - April 53.4%
 - Currently, there are approximately 36,000 Technicians and 1,762 Instructors.
- The recertification guidelines was discussed, specifically difficulties in seat check sign-offs. It
 seems that Technicians and Instructors are not understanding that an instructor or technician
 proxy must be present during a seat check. Discussion of wording for clarity and how to ensure
 uniformity of this instructor/technician proxy responsibility.
- Cass shared about the future development of an Instructor Improvement Refresher Course.
- Justin led a discussion about the possibility of holding a hybrid certification course in conjunction ion with the October 2023 full Board meeting. Discussion will continue.
- The Board discussed upcoming webinars for the NCPSB Webinar Series and needed material.

Data Committee - Denise Donaldson and Justin Young

- The committee discussed its continuation and future activities including the Child Crash Data project.
- An NDCF update was provided by Jennifer Booge, NDCF Team member.
 - 120,000 seat checks have been recorded with the NDCF.
 - Since March, there has been over 5,000 seat checks completed with the NDCF per month.
 - There are 8,851 user accounts with growth every month in new accounts
