About the Car Seat Basics for Law Enforcement National Training

The Car Seat Basics for Law Enforcement National Training was developed in partnership by the National Highway Traffic Safety Administration and the National Safety Council with the support of national subject matter experts. Car Seat Basics for Law Enforcement is a copyright of the National Safety Council.

Goals

The goals of *Car Seat Basics for Law Enforcement* are to equip law enforcement officers, who are not Child Passenger Safety Technicians, with knowledge to:

- 1. Take an active role in assessing car seat use, according to evidence-based best practices,
- 2. Talk to caregivers about child passenger safety, and
- 3. Share child passenger safety local and national resources with caregivers.

Curriculum Overview

Delivery Formats

Two delivery formats are available.

- ✓ In-person The curriculum is delivered during a 90-minute in-person session by a U.S. certified Child Passenger Safety Technician or Instructor.
- ✓ Online The curriculum is delivered in an online course with an estimated completion time of 60-90 minutes. Participants complete the course at their convenience, incrementally or all at once.

Content

Car Seat Basics for Law Enforcement is a nationally standardized curriculum delivered in a cumulative manner. The content is designed to be delivered in its entirety, in modular order, and should not be altered in any way, including addition or deletion of content. Modules and estimated delivery times are as follows.

Forward-facing Car Seats	20 min.
Booster Seats	20 min.
Seat Belts	10 min.
Connecting with Resources	10 min.
Total Training Time	90 minutes

Child Passenger Safety Technician Continuing Education Units

Car Seat Basics for Law Enforcement is a general education training and does not meet the requirements for CPST CEUs.

Completion Requirements

To successfully complete the training and earn a certificate of completion, participants must:

- ✓ Attend the in-person session in its entirety OR
- Complete the online course to 100 percent.

Delivery of the National Training

Any U.S. certified Child Passenger Safety Technician or Instructor may deliver an in-person *Car Seat Basics for Law Enforcement* course.

Since *Car Seat Basics for Law Enforcement* is a general education training, there are no instructor-to-student ratio requirements.

Curriculum Resources

Curriculum resources supporting the delivery of *Car Seat Basics for Law Enforcement* include the following:

PowerPoint Presentations

- ✓ PowerPoint presentations are available for each module of the in-person course delivery format.
- ✓ The slides in the PowerPoint presentations include key concepts and graphics to support content delivery for that module.
- The corresponding instructor notes for each PowerPoint slide are included in the Notes Page view for the slide.
- ✓ Use of the PowerPoint presentation(s) during an in-person course is required.

Online Course

The online course is delivered via the Child Passenger Safety Learning Portal free-of-charge.

Online Resource Tool

An online <u>Car Seat Basics for Law Enforcement QUICK REFERENCE</u> resource tool is available to all participants, in-person and online, at <u>carseateducation.org/csb-le</u>.

- Fit guidance

Forms for In-Person Delivery Format

- ✓ Certificate of Completion Template: A template for a certificate of completion is provided. It is suggested that a certificate of completion, print copy or via email, be given to all participants successfully meeting the training completion requirements at the end of an in-person course.
 - NOTE: Participants completing the online course will be issued a certificate of completion in the Child Passenger Safety Learning Portal.
- ✓ Course Evaluation: The course evaluation can be distributed to participants at the end of an in-person course. Customization of the course evaluation to meet local needs is permitted.

Preparing for a Course

Access Curriculum Resources

To request access to the curriculum resources, complete the <u>Car Seat Basics for Law Enforcement</u> <u>Curriculum Resources Request Form</u>. The requestor must be a U.S. certified Child Passenger Safety Technician or Instructor.

Once certification is verified, the requestor will be sent an email with a hyperlink to a shared document folder on **Box**, a cloud-based file sharing platform, to access the curriculum resources including:

- PowerPoint presentations
- Certificate of completion template
- Course evaluation

NOTE: A Box account is **not** required to access the curriculum resources.

It is strongly encouraged that curriculum resources are checked for being current prior to the delivery of each training. File names will indicate a revision date as applicable.

IN-PERSON COURSE OFFERINGS

- A digital projector connected to a computer's video output is required to deliver the PowerPoint presentations.
- It is helpful to have WiFi connectivity to access digital resources referenced in the training.
- Car seats are not required as the curriculum does not include any hands-on harnessing or installation activities.

Online Course - Group Delivery

Group delivery of the online *Car Seat Basics for Law Enforcement* course in the <u>Child Passenger Safety</u> <u>Learning Portal</u> is available free-of-charge.

Designated group administrators can assign participants to the online course, monitor progress and run course completion reports.
